- If using a high pressure washer keep nozzle at least 36" away from film edges to avoid lifting.
- After waxing your car you can remove any wax build-up along film edges with a lint-free cloth.
- Use waxes that do not contain dyes, abrasive polishes and/or rubbing compounds. 3M recommends 3M[™] Performance Finish when waxing your car.
